TEC iDendron Membership Terms & Conditions

Techno-Entrepreneurship Core (“TEC”) coordinates entrepreneurship resources and facilitates research-driven start-up initiatives at The University of Hong Kong (“HKU”). TEC offers start-up support programmes (“Programme”) and provides iDendron membership benefits on and off campus (“Membership”).

The individual, team or company (“Start-up”) has been admitted to the Membership. By accepting this Membership, the Start-up hereby understands and agrees to all terms and conditions outlined below:

1. **Co-working Space:** TEC offers office space on the following locations. The Start-up is granted access to these spaces with details specified in Appendix 1 (additional application may be required).
 - **iDendron@HKU:** 2/F, Pao Siu Loong Building, The University of Hong Kong.
 - **iDendron@Wanchai:** Room 2702, Convention and Exhibition Plaza, Office Building, 1 Harbour Road, Wan Chai (upon application).
2. **Co-working Space Regulations:** The Start-up undertakes to use the co-working space(s) in accordance with and regulations in Appendix 2 (“Regulations”). Additional agreement(s) may be required to access specific benefits offered by TEC or its partners.
3. **Publicity and Acknowledgement:** The Start-up is permitted to identify itself and use the logos owned by TEC (“TEC Logos”) as specified below:
 - (A) **Form of use:**

“A member of HKU iDendron” or “A HKU iDendron Start-up” or “香港大学 iDendron 初創社群成員”
OR
“With Support from/Supported by HKU Techno-Entrepreneurship Core/TEC”
or “獲得香港大學創中心支持”
OR
equivalent translations or abbreviations or a TEC logo as provided in Appendix 3.
 - (B) **Disclaimer:**

The following disclaimer should also be included in any publications and media events related to the Start-up:

“Any opinions, findings, conclusions or recommendations expressed in this material/ publication (or by members of this company) do not reflect the views of The University of Hong Kong or HKU Techno-Entrepreneurship Core.”

- (C) **Acknowledgement:** Acknowledgement of the TEC support should appear on facilities, publications, and publicity and media events related to the Start-up.
 - (D) **Reservation:** TEC shall reserve the right to terminate the Start-up's right to use the Co-Working Space and/or TEC Logos at any time and claim damages if the Start-up or its employee(s) misuse the Co-Working Space or TEC Logos.
 - (E) **Exemption of Liability:** TEC shall not be liable for any damage howsoever caused to the Start-up or any third party incurred by the Start-up's activities.
4. **HKU Trademark Restriction:** Without the prior written consent from HKU, the Start-up shall not use the name "The University of Hong Kong", or any variation, adaptation, or abbreviation thereof, or the name of any of HKU's trustees, officers, faculty members, or agents, or any trademark owned by HKU, in any promotional material or other public announcement or disclosure.
5. **Start-up Logos:** The Start-up hereby grants HKU and/or TEC the right to use its name or logos for non-commercial purposes.
6. **Termination:**
- (A) Either the Start-up or TEC may terminate this Membership by providing the other Party at least one (1) month's prior written notice.
 - (B) If The Start-up or its employee(s) breach(es) any obligations under the Terms & Conditions, including Regulations, and fail(s) to remedy such breaches within seven (7) days after receiving written notification by TEC, TEC reserves the right to terminate the Membership immediately without any refund.
7. **Procedures Following Termination:** Upon termination, the Start-up must return the access card(s), remove personal belongings, and restore workstations or hot desks to their original status within three (3) working days.
8. **Contact Details and Notices:** TEC may use the contact details provided by the Start-up. The Start-up is responsible for providing accurate contact information and cannot hold TEC or HKU liable for any missed notices. The Start-up will be auto-subscribed to TEC's email list and social media platforms.
9. **Privacy:** The Start-up agrees that TEC and HKU may use, disclose, verify, or transfer any information (including personal data) provided by the Start-up for service provision under the Terms & Conditions or in compliance with applicable laws and regulations.
